MEMORANDUM OF UNDERSTANDING BETWEEN THE YOUTH MENTAL HEALTH FIRST AID PROGRAM IN AUSTRALIA AND *(NAME OF ORGANISATION AND COUNTRY)*

1. This Memorandum of Understanding embodies the understandings of the Mental Health First Aid Training and Research Program in Australia ("MHFA Australia") and *(name of organisation/consortium)* (hereinafter referred to as "the Parties") on the use of the Youth MHFA Australia Edition two ("YMHFA") materials in *(name of country)*.
2. The Parties share a common desire to improve mental health literacy based on:
 - sound scientific evidence and expert consensus
 - high standards in the teaching of instructors of the YMHFA Program
 - the dissemination of the YMHFA Australia materials or adapted versions in *(name of country)*.
3. Betty Ann Kitchener and/or Anthony Francis Jorm are the copyright holders of some of the materials in the YMHFA Program, namely the YMHFA manual, the Instructor teaching notes and the teaching PowerPoint slides.
4. Betty Ann Kitchener and Anthony Francis Jorm grant *(name of organisation/consortium)* permission to use their copyrighted YMHFA materials to be incorporated in the *(name of country)* version of the YMHFA Program for a fee of AUD\$.....negotiated between the Parties. There is a separate Licence Agreement for use of film clips used in the YMHFA course.
5. Betty Ann Kitchener and Anthony Francis Jorm grant *(name of organisation/consortium)* permission to develop the *(name of country)* version of a YMHFA Instructor training package and for use only in *(name of country)*.
6. Any publications produced by *(name of organisation)* based on the YMHFA Australia materials will acknowledge that YMHFA Australia has been a source for these publications.
Suggested text to include in *(name of organisation/consortium)*'s MHFA manual:

"This manual incorporates material from: Kitchener BA & Jorm AF. (2007) Youth Mental Health First Aid: A Manual for Adults Assisting Youth. ORYGEN Youth Health Research Centre, Melbourne. This material is copyright to Betty Kitchener and Anthony Jorm and cannot be reproduced, stored in a retrieval system, transmitted in any form or by any means, electronic, mechanical, photocopying, recording or otherwise, without the prior permission of the original copyright holders".
7. *(Name of organisation/consortium)* acknowledges that Betty Ann Kitchener and Anthony Francis Jorm are the international copyright holders for YMHFA Australia materials and that:
 - Kitchener and Jorm have granted non-exclusive permission for only *(name of organisation/consortium)* to reproduce its copyright materials for use only in *(name of country)*.
 - Kitchener and Jorm alone can authorise other organisations to reproduce its copyright materials.

- (Name of organisation/consortium) cannot in turn delegate Kitchener and Jorm’s permission to reproduce its copyright materials to any other organisation.

8. (Name of organisation/consortium), in accordance with the Parties’ aims in Item 2 above, agrees to provide copies for reference purpose only of its published materials to YMHFA Australia on a no-fee basis.

9. YMHFA Australia acknowledges (name of organisation/consortium)’s copyright in any materials provided to YMHFA Australia.

10. YMHFA Australia will include the appropriate academic references and acknowledgement when referring to (name of organisation/consortium)’s materials.

11. In accordance with the aims in Item 2 above, the Parties agree to provide each other with copies for reference purpose only of any new MHFA materials developed.

12. (Name of organisation/consortium) agrees to support the formation of the proposed international organisation provisionally named Mental Health First Aid International. The aims of this organisation are, provisionally:

- to link together various MHFA training programs around the world
- to facilitate sharing of information between these programs in different parts of the world
- to organise periodical international conferences.

13. This Memorandum is effective for a period of five (5) years. It comes into effect on the date of signing and remains in effect for the next five years, unless one of the Parties notifies in writing the other Party of its intention to terminate at least six months in advance of termination.
